Compliance with NEPA – Spring 2022

<u>Course Description:</u> Compliance with the National Environmental Policy Act: This course will provide the essentials of NEPA, how to work on an interdisciplinary team to prepare NEPA documentation (Environmental Assessments [EAs] and Environmental Impact Statements [EISs]) and how to review these documents.

<u>Student Learning Outcomes</u>: Upon successful completion of this course:

- 1. Students will be able to communicate what NEPA does and how the NEPA process works with emphasis on how to identify significant impacts, how to develop appropriate alternatives, effective public involvement strategies, NEPA's relationship to other environmental regulation and planning processes.
- 2. Students will be able to complete the EA process, keeping documents concise while fulfilling the legal and ethical requirements.
- 3. Students will be able to complete the EIS process, keeping documents concise while fulfilling the legal and ethical requirements.
- Students will be able to crucially evaluate and review NEPA documents and communicate those comments in appropriate written submittals.
- 5. Graduate student will be able to research and present advanced understanding of a specific area of NEPA in addition to the four objectives above.

Course Requirements:

- 1. Lecture. This course is lecture, discussion and activity oriented. Students are expected to attend class regularly and to be active participants in class lectures and discussions (including 20 Participation and Attendance Checks [PACs] WebCampus polls / activities / quizzes). Attendance is essential for student success. Students who miss a class session are responsible for finding out what they missed before the next class. Laptops and phones should only be used for specific class activities during class time. Arriving late, leaving early and talking to classmates during lecture disrupts the learning environment.
- 2. Assignments. Assignments are DUE AT 5:00 p.m. submitted to WebCampus on the due date indicated in attached Course Schedule. Late assignments will not be accepted.
- 3. Tests. There will be two (2) online tests given (Mid-term and Final). In this course, you will be required to complete one (1) proctored online exams using the remote proctoring service, **Proctorio**. Students will be required to show identification in order to enter the exam, and allow for the recording of the testing area via webcam and microphone. The Mid-term exam via Proctorio will take place during the period of March 10-23, 2022. The take-home Final exam will take place during the period of May 3-10, 2022. Students will be allowed 6 hours to complete each exam.

At least one Identity Verification Assessment or experience per course, where students are required to present photo identification upon beginning the assessment is required of an accredited university.
